


STRATEGIC LEVEL

The Strategic Level consists of the E3, P3 and F3 subjects and one case study. This level focuses on making strategic decisions for the long term and the exams are online, objective style and 90 minutes long.

The case study combines the knowledge and learning across the three subjects. It is set within a simulated business context based on a real business or industry, and focuses on application, analysis and evaluation. The case study exam is online, three hours long and incorporates calculations, short answers and essay.
